1 Upon the recommendation of the Class Administrator in this case and the request of the  
2 Plaintiffs as set forth in Plaintiffs' counsel's letter to the Court dated September 9, 2009, and with  
3 the consent of the Defendant, the Court finds that good cause exists to AMEND its July 17, 2009,  
4 Order Amending Final Plan of Distribution of Judgment as follows:


5 1. The final sentence of Paragraph 5 of that Order is amended to provide that "Any such  
6 checks must be negotiated on or before October 31, 2009, and shall be void thereafter."

7 2. Paragraph 8 of that Order is amended to provide that "In November 2009, Plaintiffs'  
8 counsel shall provide the Court with a report regarding the results of these additional distribution  
9 efforts and the expenses incurred.

10 3. In all other respects, the Order Regarding Distribution and the Order Amending Final  
11 Plan of Distribution of Judgment shall remain in effect.
